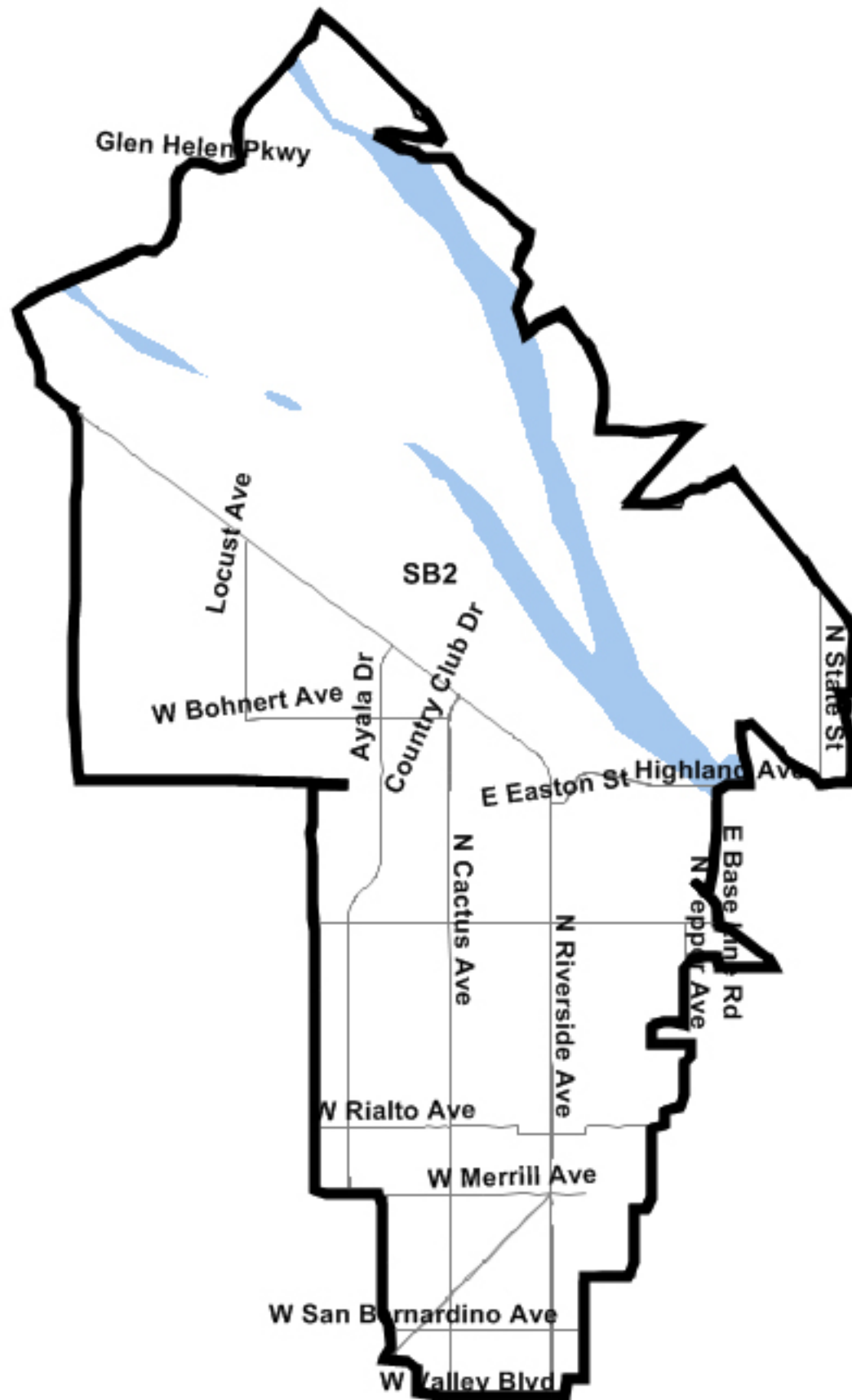

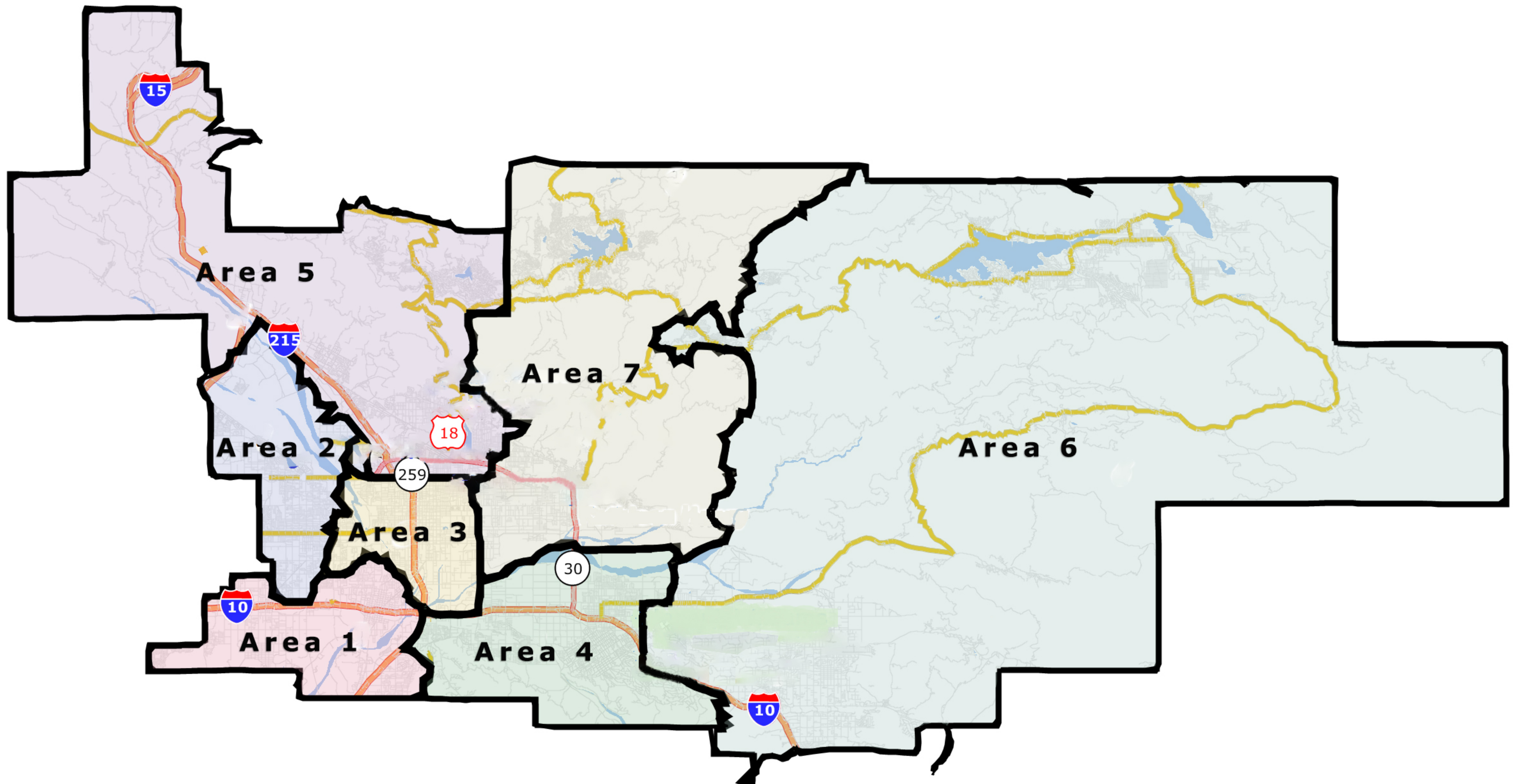

Except for beginning at the point of intersection of State 210 Hwy and N Linden Ave, and proceeding easterly along State 210 Hwy to nonvisible boundary, and proceeding westerly along nonvisible boundary to N Linden Ave, and proceeding southerly along N Linden Ave to the point of beginning. 4. As well as beginning at the point of intersection of Ford St and Oak St, and proceeding easterly along Ford St to Oak St, and proceeding westerly along Oak St to the point of beginning.
